| 1 | The total number of sections of the school shall be restricted to 12, out of which 1/3 shall be used for Senior Secondary classes. Any further increase shall require prior approval of the Board subject to compliance with affiliation bye laws and availability of rooms of 500 sq. ft. dimension. |
| 2 | It is observed from the video that the hostel and school are in the same building. The school should shift the hostel from the school building and the hostel should be cordoned off and submit the compliance through videography within 3 months on SARAS portal. |
| 3 | The school should follow the guidelines for Residential School issued by the board vide Circular no. 24 dated 01.09.2023. |
| 4 | The Maths Lab is still understocked and without adequate storage. The school should upgrade the Math lab in the light of the SOPs issued by the Board vide circular no. 11 dated 04.10.2022 and submit the compliance within 3 months on SARAS portal. |
| 5 | The composite lab is under stocked and not properly laid out.equipment are seen on wooden tables .no chemistry section is seen.there are no metal/stone topped work stations with utilities(piped gas and water supply).No storage is seen and plastic chairs(inappropriate for a lab) are seen instead of wooden stools. Biology lab has no work stations with utilities.only wooden tables are seen.All labs have plastic chairs |

| | instead of metal/wooden stools The school shall upgrade all the science labs strictly as per Sop issued by the Board within 3months and submit compliance on SARAS with videography. |
| 6 | The school should maintain Accession Register in the Library. The school is required to increase the variety of genre of library books like Fictions, non fictions, autobiography, encyclopedia, self help books . 6 news papers and 10 magazines should be subscribed as per CBSE guidelines and submit the compliance on the SARAS portal within 3 months. |
| 7 | The school has overlaid a ramp on part of steps at the entrance of the building, which is too steep and unsafe. The school shall dismantle it and construct a proper ramp with hand rails as per norms of RPwD Act and guidelines issued by the board within 3months and submit compliance on SARAS with videography. |
| 8 | The school has overlaid a ramp on part of a staircase which is too steep and unsafe for CWSn. The school shall dismantle the same and construct a proper ramp as per norms of RPwD Act and guidelines issued by the Board or install a lift within 3months and submit compliance on SARAS with videography. |
| 9 | Only 1 CWSN toilet is seen in the video. The same is not as per norms and hence not acceptable. The WC is on a raised platform and there is no space for a wheelchair/walker to navigate. There is no CWSN toilet on second floor. The school shall construct separate toilets for CWSN boys on every floor as per norms of RPwD Act and guidelines issued by the Board within 3months and submit compliance on SARAS with videography. |
| 10 | The school shall conduct mandatory training of its teachers with CoE Ajmer within 3 months and submit compliance on SARAS . |

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school shall renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.

9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted within the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
